

# NC-804 AIR FORCE JROTC CADET CONTRACT

## APPLICATION AND AGREEMENT FOR:

1. **UNDERSTANDING:** Belonging to the cadet corps is a privilege and not a right. The staff reserves the right to remove anyone from the program if they are not meeting the minimum standards spelled out in this contract and the NC-804 Cadet Guide.
2. **OBLIGATIONS AND CONSIDERATIONS:** Participation in AFJROTC does NOT commit or obligate any student to military service. It does not guarantee special consideration if a student chooses to enter any service. However, a cadet who completes two to three years of AFJROTC may qualify for advanced rank upon enlistment in the military. Additionally, students who complete two years of AFJROTC and are enrolled in their senior year are typically more competitive for AFROTC scholarships.
3. **APPLICATION:** I, the above-named cadet, hereby voluntarily enroll in the NC-804 Air Force JROTC Program (Eastern Wayne High School).
4. **AGREEMENT: (Aerospace Science Instructors)** Upon acceptance of this application and the fulfillment of the conditions on the part of the cadet, the Senior Aerospace Science Instructor (SASI) and the Aerospace Science Instructor (ASI) agree to: (1) Help develop citizens of character, dedicated to serving others (2) Instill responsibility, character, accountability and self-discipline (3) Provide instruction in air and space fundamentals, leadership education, and military drill (4) encourage physical fitness (5) Familiarize the students with the Air Force and the scholarship and career opportunities that it offers to qualified graduates. (6) Run a fully compliant AFJROTC program as mandated by the Air Force.
5. **AGREEMENT: (Cadet)** As a cadet in the program, I understand and agree to:
  - A. Meet the program requirements and standards as mandated by the Air Force and NC-804 as specified in the NC-804 Cadet Guide. I understand that according to the contract between the Air Force and Wayne County Public Schools (as well as AFJROTC Instruction 36-2001) membership in the cadet corps must be limited to those cadets who are voluntarily enrolled and meet and maintain all program requirements. Program requirements include: taking AFJROTC academic courses, participation in cadet corps activities, properly wearing prescribed uniform each required uniform day (typically once a week), meeting and maintaining Air Force grooming standards, and maintaining acceptable disciplinary standards (inside and outside of AFJROTC). I understand cadets who are consistently deficient in one or more of the areas of the program or demonstrate a negative pattern of behavior are disruptive to the overall corps operations and must be disenrolled.
  - B. Wear the regulation Air Force uniform on those occasions prescribed by the SASI and maintain the personal dress and grooming standards established by the Air Force. I will pay particular attention to **military haircut standards, facial hair, body piercing, tattoos, makeup, and body jewelry**, as described in NC-804 Cadet Guide and AFI 36-2903. I know that Uniform Day is typically every Wednesday and cadets are inspected for a grade. I have read and understand the following from the NC-804 Cadet Guide:
    1. Cadets failing to wear the uniform on uniform day without a valid parental/guardian note approved by SASI/ASI, will receive a 0% grade for that days uniform inspection (i.e. uniform

in the cleaners is not considered a valid excuse unless there are very special circumstances). **Cadets with flagrant disregard for appearance and grooming standards (i.e. pink/blue hair, beard, gross bulk, nose ring, etc.) will receive an automatic 0% grade for that uniform inspection.** The first time this happens in a semester, the cadet will be counseled, and documentation will be sent home for parent/guardian to sign. The second time this happens in a semester, the cadet will be counseled, documentation will be sent to the school administrators and home for a parent/guardian to sign. Parent/guardian will also be contacted. **The third time this happens in a semester, the cadet has automatically “failed” AFJROTC (regardless of other grades) and disenrollment will begin.** Cadet will also be required to return the uniform. Note: cadets with flagrant uniform and/or appearance violations (in uniform), will be asked to change into civilian clothes, if available. If not available, will call parent/guardian to bring cadet a change of clothes so Air Force uniform isn’t disrespected, and Air Force image tarnished.

2. Uniform inspections and grading will begin the second week of the semester. At that time, if a uniform hasn’t been issued (i.e. new cadets), I understand I will get inspected and graded on adherence to required grooming standards which will be taught the first week of school.
- C. Protect and properly maintain the uniform in a clean, ironed/pressed, properly fitted, and repaired manner. I will keep my uniform shoes polished. I understand I must plan ahead to maintain standards, and effectively communicate requirements to parent/guardian in advance. I understand I am responsible for my uniform once issued to me. I will turn in the complete uniform upon demand. I am responsible for the cost of properly cleaning uniform items and reimbursement in the case of loss, theft, or negligent damage. All uniforms must be returned dry-cleaned and in still in cellophane bags with receipts attached.
  - D. Maintain an acceptable standard of academic performance in all classes. I will complete all assignments given to me by my instructors. I will be active in classroom work and strive to participate in AFJROTC co-curricular activities. I must earn a final grade of a “B” or better in AFJROTC and a “C” or better overall Grade Point Average to be eligible for AFJROTC the next semester/year without a waiver from the SASI. I understand that a final grade of “F” in AFJROTC will result in my not being allowed to re-enroll in AFJROTC.
  - E. Participate in the Wellness/Physical Training (PT) portion of the AFJROTC curriculum. I understand one day a week will be dedicated to Wellness/PT and I will be graded on participation and if I wear the issued NC-804 PT uniform (NOTE: proper shoes required to participate and be in uniform). I understand and will comply with Chapter 9 of NC-804 Cadet Guide.
  - F. Respond positively to other cadets who have been appointed to leadership positions in the Cadet Corps. I will render proper military courtesies to instructors and other cadets with senior rank. I will express courtesy and respect to administrators, teachers, coaches, and other adults with whom I come into contact. I will conduct myself properly at all times and will set the example when entrusted with a position of leadership.
  - G. Meet the objectives of the Cadet Corps by seeking to: (1) exhibit a high degree of personal honor, self-discipline, and leadership, (2) Develop inner desire to serve others, (3) develop habits of orderliness and precision, (4) promote patriotism and strengthen character, (5) develop a respect for constituted authority, (6) develop the ability to perform basic skills associated with drill and ceremonies, (7) acquire broad-based knowledge of the aerospace age and environment, (8) promote a healthy lifestyle, and (9) have fun.
  - H. Develop self-discipline and accept personal responsibility for my actions.
