SUBJECT: Thirty-Ninth Annual JROTC Red and White All American Classic Drill Meet

1. General

- A. Purpose: This Letter of Instruction (LOI) and attachments provide information concerning administration and operation of the Seventy- First High School Thirty-Eighth Annual Junior ROTC Drill Meet to be held on **27 October 2018** at Seventy First High School.
- B. Scope: The LOI applies to all participants at the meet. All Junior ROTC Advisors will ensure those attending are familiar with the contents contained herein. The Drill Meet Coordinator will clarify any questions regarding the instructions contained herein.

2. Administration

- A. Location: Seventy-First High School is located approximately five minutes southwest of Fayetteville on U.S. 401 South (Raeford Rd).
- B. Lodging: Participating units will be responsible for their lodging, if required.
- C. Meals: Full meals will not be available at Seventy- First High School. Several restaurants and fast food places are available a short distance from the school. Hamburgers, hot dogs, pizza, soft drinks, and assorted snacks will be sold in the school cafeteria. For your convenience the cafeteria area can also be used to store your gear for the drill meet.
- D. Fees: A registration fee of \$50.00 per school and an entry fee of \$15.00 per event entered will be charged for the cost of the awards. The registration fee and entry fees are nonrefundable in the event a school does not attend. Make all checks payable to: Drill Meet, Seventy-First High School.
- E. Entry Forms: Must be completed and returned no later than the date stated in the invitation letter. No school will be permitted to enter the meet after **01 October 2018**. At this time, events will be finalized based on the minimum required entries for an event. If an event is canceled, the schools concerned will be notified and entry fees for that event will be returned.
- F. Event Requirements: Only those events in attachment 2 may be entered and each school will be permitted to enter only one team or individual in each event. We must have a minimum of three entries in an event the day of the meet.

- G. Commander's Meeting: A meeting of the Advisors and Drill Team Commanders will be held at 0800 hours in the JROTC Classroom (Room 929) to discuss any problems. We will try to mail the order of participation (matrix) to each school in advance. If this is not possible, the order of participation will be announced at this meeting.
- H. Final Registration: Final registration and check-in will take place in the ROTC classroom, by 0800 hours, 27 October 2018. Any adjustments to the drill schedule or entries will be made at this time. Drill Competition will commence at 0900 hours.
- I. Awards: First, Second, and Third place awards will be presented for each event. A First, Second, and Third place overall award will also be given. Points for each event will be awarded as follows: First Place 7 points

Second Place - 5 points Third Place - 3 points Event Entry - 1 point

- J. Weapons Security: Security of Weapons will be the responsibility of individuals and/or the school's responsibility.
- K. Personal Property: No means are available at Seventy-First Senior High School to guard or to store personal clothing and/or equipment. Facilities will be provided if uniform changes are required. Schools are encouraged to use buses for changing of uniforms.
- L. Injury and Damages: The United States Air Force, Headquarters Air Force ROTC, Seventy- First Senior High School or the Cumberland County Board of Education will not be held responsible for injury occurring at the Drill Meet or other malicious damage caused by an individual to personal or school property. Any expenses incurred for such will be the full responsibility of the party or parties concerned.
- 3. Operations
- A. Command Post: The Official Command Post will be located in the Seventy-First High School JROTC Area. All announcements, schedules, and official business will be conducted from this area.
- B. Weapons: There will be no restrictions on the type of weapons used in the drill competition. Firing of the weapons is not permitted at any time while on the school campus. Bayonets will not be allowed on school campus.
- C. Awards Ceremony: Awards will be presented in the school auditorium after all the competitions are completed and scores have been tallied and finalized.
- D. Uniforms: The military uniform, including headgear, will be worn by the participants in all Regulation Drill. Fatigues will not be worn for Regulation Drill. The uniform for Fancy Drill will be at the discretion of the particular school. Bearing and Appearance will be judged on uniformity and neatness of the uniform worn by the unit.

E. Unit Size

- (1) Regulation Drill for Flight/Platoon will consist of a minimum of 13 cadets and a maximum of 21 cadets, including the Flight/Platoon Leader and the Flight/Platoon Sergeant.
- (2) Regulation Drill for Element/Squad will consist of a minimum of 7 cadets and a maximum of 12 cadets, including the Element/Squad Leader.
- (3) Color Guard will consist of a minimum of 4 cadets.
- (4) Fancy Flight/Platoon will consist of a minimum of 13 cadets and a maximum of 21 cadets.
- (5) Fancy Element/Squad will consist of a minimum of 7 cadets and a maximum of 12 cadets.
- F. Drill Pad Size: Under Attachment 17 and 18, are the Drill Pad Area maps. All of the Flight/Platoon and Element/Squad events including Regulation and Fancy, and Color Guard will be 60' by 100' pad. All Individual events including Regulation and Fancy will be on a 30' by 50' drill pad.
- G. Schedule of Events: The proposed time schedule of activities are indicated in Attachment 1. Any changes in this schedule will be forwarded to participating units if time permits.
- H. Judges and Scoring: Judges will be composed of Active Duty and Reserve Air Force and Army Personnel, and senior ROTC cadets. We will try to obtain the best qualified judges possible. The senior ranking individual will usually be designated "Head Judge." The event scores will be the average of the three judges' scores. In case of a tie between schools, the Head Judge's score of the event will be turned into the Command Post for tabulation. At no time will an individual contact the Judges or Score Keepers regarding scores.
- 4. Description of Events
- A. Regulation Drill: These events will be judged in accordance with AFM 36-2203, Army TC 3-21.5, and MCO P5060.20. Each cadet or team should be in the designated area at least 5 minutes prior to the start of an event. Penalties will be assessed at the discretion of the Head Judge for late arrival. All commands will be given by memory.
- B. Individual Regulation Drill with Weapons: The event will consist of two cadets; one cadet to perform the movements within the drill pad, and a second cadet who will call the commands for the event. All commands must be memorized and executed in sequence, and the individual calling the commands will not be required to conduct the movements.
- C. Flight/Platoon and Element/Squad: These events will consist of Flight/Platoon or Element/Squad with or without weapons in accordance with AFM 36-2203, Army TC 3-21.5, or MCO P5060.20.

- (1) Drill teams should be in the ready area at least 5 minutes before their scheduled start times. Penalties will be assessed at the discretion of the Head Judge if a team does not report to the drill area when called. To avoid late penalties, each team should report to the ready area as the previous team enters the drill area. There will be an official in the ready area. The commander may move his unit on the drill area in any manner that he wishes. Judging/Timing will start as soon as the first command is given; from the drill pad, by the Flight or Element Leader or when the team breaks the boundary line, which ever occurs first.
- (2) All movements will be on the order of the Drill Team Commander, and will be according to this Letter of Instructions and the sequence listed on the score sheet. The score sheets list only the movements, not necessarily the correct command. The Drill Team Commander must commit all sequences and commands to memory. There will be penalties assessed for the following: (a) late arrival at the assembly area for competition, (b) giving commands from notes, (c) crossing a boundary line during a performance, (d) incorrect sequence of the command, (e) deviations from the drill manual, and (f) departing the drill field at the incorrect place. The drill area for the sequences will be sixty feet by one hundred feet (Attachment 17).
- D. Color Guard: Only regulation color guard movements will be allowed in accordance with AFM 36-2203, Army TC 3-21.5, and MCO P5060.20. All movements will be on the order of the Color Guard Commander and in the sequence listed on the score sheet. Each team will report to the ready area at least 5 minutes before starting time. The same penalties as 4C (2), above, apply. Drill area size will be sixty feet by one hundred feet.
- E. Fancy Drill: This competition is limited only by the ingenuity and skills of the participating units using movements and steps. This is not a dance type drill. The following are prohibited: (a) use of lights, luminous paints, explosives, fireworks, flares, or other pyrotechnics; (b) music, loud speakers, or other means of keeping cadence with the exception of voices; (c) the firing of weapons. Uniforms will be up to the discretion of the units and be of original design. However, general appearance, including neatness and military bearing, can affect the judge's opinion. There will be three scoring judges circulating around the drill area.
- F. Fancy Individual: Individuals should be in the ready area five minutes before their starting time. The Head Judge will give the signal for an individual to begin. The sequence may begin within or outside the drill area. The sequence will last from three to five minutes. One penalty point will be assessed for every second below the three minutes or above five minutes.
- G. Fancy Flight or Element: Each team should be in the ready area at least five minutes before their staring time. Penalties will be assessed at the discretion of the Head Judge if a team is late for its starting time. An official will be at the ready area. Immediately on signal, the team will enter the drill area and will end when the last person leaves the drill area. Each team has from five minutes to seven minutes to complete their routines. One point will be deducted for every second below five minutes or above seven minutes.

- 5. Penalties: Penalties will be assessed as follows:
- A. Late arrival at the ready area or causing delay in the meet: 1 point per minute over specified time.
- B. Crossing a boundary line during performance; 10 points of the maximum score.
- C. Departing the drill area at any point other than specified point of exit; 15 points of the maximum possible score.
- D. Failure to adhere to specified time limits; one point per second over or under specified time.
- E. Extraneous personnel on the drill floor; 1 point per cadet over or under the specified number.
- F. Any action considered by the judge to be in poor taste or not keeping with the traditions of good sportsmanship and fair play. The amount of points assessed is at the discretion of the Head Judge based on the seriousness of the infraction.
- G. Unauthorized contact with the judges or score-computing official; 25 points of the possible score.
- H. Giving commands from notes; half of the possible score.
